Tracy Borst Receives the IIMC National Award

Tracy Borst was first elected as Town Clerk of Thetford in 2003 and has served the town for over 20 years. She is a Certified Municipal Clerk, a Vermont Certified Municipal Clerk Summa Cum Laude and a Master Municipal Clerk. She has been on the Board of Directors of NEMCI (New England Municipal Clerk's Institute & Academy) since 2016, serving as its Chair from November 2019 through November 2022. She is currently the Fourth Vice President of the New England Association of City & Town Clerk's Association (NEACTC).

Many letters of recommendation and support for Tracy to be honored with the IIMC 2023 Institute Director Award of Excellence. Jim Ognibene of Visioneer Learning stated, "Tracy Borst, while serving as New England Municipal Clerks Institute Director, led the process of bringing clerk education online. She let this and many other projects to make sure the Institute continued to serve the clerk community during COVID and post-COVID. These online educational offerings were extended to all clerks nationwide and in Canada. We celebrate these wonderful accomplishments."



In the award announcement, IIMC Executive Director Chris Shalby noted: "We value our Institute Directors highly and are cognizant of the effort, work and passion that they provide to help our members regarding their professional development."

The award was established by IIMC in 1994 to acknowledge the exceptional contributions made by an Institute Director in promoting quality education for municipal clerks. This is a well-deserved honor to recognize Tracy's dedication to clerk education."

On a personal note, I have worked on and off with Tracy as the Selectboard assistant since returning to Vermont in 1999. Her dedication to clerk education is matched with her dedication to the residents of Thetford, and to all the personnel who work with her in the Town Hall. I was honored to be appointed as her assistant in 2020, while she deftly adapted to COVID restrictions while maintaining consistent service to the Town of Thetford. Not to mention running a smooth Presidential Election during a lock-down.

It has been my pleasure to work with Tracy and to support her while she continues to devote herself to the amazing people we call Municipal Clerks. Congratulations again, Tracy!

In Vermont, approximately ten active clerks have this prestigious designation; in the United States, there are 1475, according to the IIMC list.

The MMC program is the second and more advanced of the two professional designations granted by IIMC. The MMC program is an advanced continuing educa-

tion program that prepares participants to perform complex municipal duties. The program has an extensive and rigorous educational component and a professional contribution component. MMC applicants must demonstrate that they have actively pursued education and professional activities.

Deb Tanguay, Town Clerk of Coventry, on earning the prestigious Certified Municipal Clerk, CMC, designation from the International Institute of Municipal Clerks (IIMC) in January 2023.

Sue Moraska, Assistant Clerk, Town of Shelburne, earned CMC, in June 2023.

This honor was achieved after training and community and professional service. Vermont has 17 CMCs among the active clerks with a total of 21 on the current IIMC list since 1996. Nationally, there are 4604.

In Vermont absentee voting is accessible to all registered voters; when requested absentee ballots for all major parties are mailed to the registered voter, ensuring they can participate in the primary of their choice. They must return their voted ballot in the voted ballot envelope and must return their unvoted ballots in the unvoted ballot envelope; together both of these envelopes must be returned to the town clerk by election day to be counted. If the unvoted ballots are not returned, the entire vote is spoiled. As we prepare for this primary election, we remind voters to carefully follow the instructions for returning their ballots to ensure their voices are heard. The November General Election will be here soon enough, with the state mailing ballots to all registered voters.

Things You Save in a Fire by Katherine Center

About this book: This book is not one of my usual choices; it's fiction, a story about a female firefighter who moves from Texas to Boston. We will discuss cultural differences, the gender gap, her vulnerability and bullying. But there is a love story weaved into this book too. I hope you enjoy this easy read during a Presidential Election season.

"Cassie Hanwell was born for emergencies. As one of the only female firefighters in her Texas firehouse, she's seen her fair share of them, and she's a total pro at other people's tragedies. But when her estranged and ailing mother asks her to give up her whole life and move to Boston, Cassie suddenly has an emergency of her own. Katherine Center's *Things You Save in a Fire* is a heartfelt and healing tour-de-force about the strength of vulnerability, the nourishing magic of forgiveness, and the life-changing power of defining courage, at last, for yourself." Engage actively with the material, and don't hesitate to share your thoughts and insights with your peers. This will enhance not only your understanding but also the collective learning experience.



Legislative Committee Update

Vermont Clerks and Treasurers are seeing the results of the 2024 Legislature start to filter down. The first to hit our locales, is the post Covid version of Vermont's Open Meeting Law. The change calls for select boards, and committees deemed essential, to hold hybrid meetings, both in person and on line, with the recordings to be available on line afterward. Towns large and small are still trying to sort out the changes.

A change that needs to be watched closely, is a new law governing tax abatements and tax sales. As often happens, an ad hoc committee is helping work out the fine details, with one VMCTA member as yet to be named on the committee.

A request from several Clerk's was included in an election bill, as firearms are no longer allowed at the polls or at the locations of early voting.

The fine print of a municipal ethics law still needs to be worked out, including the reporting and resolution of complaints.

Vermont will have a new division of animal welfare within the state public safety department, to be funded next year by a two dollar surcharge of dog license. One request from several Clerks, is to have veterinarians be required to send rabies certificates either to the Towns of a dog's origin, or to a central data base.

Next year promises to be dominated by election law changes, including ranked choice voting on state and federal elections. It is hoped the start date will be pushed back to give election workers time for proper training.

The position of chair for the V M C T A legislative was a fast and furious baptism into lobbying. I spent a considerable amount of time consulting long time chair Carol Dawes, both before and after her retirement as Barre City Clerk and Treasurer. It's a huge task, but I'm grateful for the opportunity.

Tips & Tricks!

Absentee Ballots

Here are my tips and tricks for dealing with absentee ballots.


- I always have a number of ballots and envelopes ready to grab and go. I include all envelopes and ballots in the outside envelope.
- I leave the Declaration of Voter envelope sticking up from the outside envelope. When I issue a ballot, I write the voters name on the Declaration envelope. This way I know who is sending back a ballot even if they forget to sign it or I cannot read their writing. If

I am mailing a batch of ballots, I print two sets of labels, one with a barcode and one without. This makes checking them out and back in much faster.

- I highlight the signature line to help people remember to sign the envelope.
- When the ballots are returned, I check them in and file them in alphabetical order, this makes it easy to find any voter quickly if we need to. We also check each ballot against the voter check list before putting them in

the tablulator. Keeping them in alphabetical order helps with this.

In his characteristic sense of humor, Jenne said he really enjoyed being Town Clerk. "You're selling a product they can't get anywhere else, and they know they need it. When I hired Emma Sawyer, and (then, new Town Clerk) Brian Stroffolino, I was getting the office into the 21st century."

Stroffolino called his predecessor as clerk, "an amazing wealth of knowledge who continues to support us." He still brings in doughnuts once a week.

Being a long time clerk, and a fixture at many regional and state meetings, does Jenne still hold some secrets? "Well, everybody knows I'm not left handed, and that I'm gay, but did you know I'm on a piece of land settled by my ancestors?"

While managing all the City Clerk duties, Kinville also earned her MMC, and the advanced certification of CVC (Magna cum Laude in 2021). She served as President of the VMCTA from 2017 to 2019 and was the Vermont Clerk of the Year in 2021.

City Council Chair Helen Riehle even declared August 17 as Donna S Kinville Day and announced that the official vault

You Can Do It!

The deadline for getting in your application for certification is July 31. While it is tight, it is not impossible to put in order those certificates you have been saving in the file and fill out the application. Postmark of July 31 is considered on time.

If you can't quite face another task this summer, there may be an opportunity to apply before next July. The Certification and Education Committee has spent a bit of time on its role and made recommendations to the Executive Board to split the two large tasks (education and certification) into two different, yet collaborative, groups. And, also to have two separate deadlines so our members can move forward on their certifications. Watch for an update on these and other recommendations as the two groups have been in discussion, working out the details.

In the meantime, here are some tips to streamline your application:

1. Print the application level to which you will be next applying and put it in a folder.
2. Download or save your certificates to a file on your computer in place you can remember to find it. Mine is VMCTA Certification.
3. Print the certificate and put the corresponding application requirement number on the top right-hand corner and put it in the folder with your application.
4. If you attend VMCTA meetings as a committee member or your County Committee meetings, print the first page with attendance, circle your name and drop it into the folder. (Speaking from experience, it is a lot of work to comb through emails to find minutes, so get in the habit of keeping up with paperwork as it arrives.)

I have found that keeping a list of what I need for each requirement (and the points) gives me a quick overview of the work I need to do to complete the application. So, a First Thursday (.5 point), Visioneer online class (usually one point) or an Athenian Dialogue (three points) might finish the application before the deadline.

Finally, feel free to contact a Certification Committee member, if you have questions. We are always happy to help you - and, we have all done this at least once!
